Policy CH1: Local Green Space Designation

Designating Local Green Space Consultation 25.3.17

Consultation took place on March 25th 2017 where residents were asked to comment on nine areas identified as important local green spaces (listed below). They were asked whether they agreed with these green spaces being designated and what its value was to them. 52 residents attended and 34 forms were completed providing very useful feedback. A summary of the comments is detailed below.

Frank Henson Gibbings Memorial Park – *Recreational Value, Historic significance, Tranquillity*

Football Club Field, The Wardens, Exeter St- *Recreational Value*

Rugby Field & Practice Field, Taw Meadows - *Recreational Value, Tranquillity, Beauty, Richness of its wildlife*

The Depot, Devonshire Gardens – *Recreational Value, Richness of Wildlife, Tranquillity*

St Peter’s Churchyard - *Historic Significance, Tranquillity, Beauty, Richness of its Wildlife*

North Tawton Cemetery & Extension – *Historic Significance, Tranquillity, Richness of its Wildlife, Beauty*

Allotments, behind Fore St - *Historic Significance, Recreational Value, Richness of its Wildlife, Tranquillity*
